## VI. TERMS & CONDITIONS

1. The conditions prescribed in the By-Laws and the Rulebook of World Trade Centre – Hong Kong International Airport Membership are binding on all members of World Trade Centre – Hong Kong International Airport and constituting a contract between World Trade Centre – Hong Kong International Airport and the Member as if signed by each party. By signing the Application from to become a Member of World Trade Centre – Hong Kong International Airport, the prospective Member agrees to be bound by these conditions of membership and regulations.
2. World Trade Centre – Hong Kong International Airport Membership Management may at its absolute discretion and without assigning any reason accept or reject any application. A Joining Fee will be charged for possessing a membership in such amount as prescribed by World Trade Centre – Hong Kong International Airport Membership Management and is non-refundable.
3. Membership Cards are issued to each Member and can only be used by the Member to whom it is issued. A Member who fails to present his Membership card may be refused entry into Airport World Trade Centre Club premises or the provision of any goods and services.
4. Monthly Subscriptions are non refundable. .
5. Changes of Nominee Under Corporate Membership

A Corporate Member may apply or change its nominee and re-nominate other partners, directors or employees of the company to become the nominee under the Corporate Membership. Any application for nomination must be officially submitted to the Membership office of World Trade Centre – Hong Kong International Airport by a “Corporate Membership Re-nomination Form”. The Corporate Member shall be liable for all charges and expenses on or before the effective date of such transfer if and when it is accepted by World Trade Centre – Hong Kong International Airport..

6. Transfer of Membership

All memberships are non-transferable except the Corporate Membership.
